Terrica

Terrica's young adult life was a cycle of addiction, jail, and homelessness. After being hit and dragged by a car, she reached her breaking point during recovery and remembered Ready to Work, a program her brother once mentioned, "It had to be better than standing on a corner." She unknowingly craved the structure, and path forward in building a fresh start with purpose. She now has her own place, two jobs. "The routine, the income, and work in the community motivated me. Now I have a home and everything I want— everything I need."



Ryan

When Ryan lost his home, wife, and dogs, he ended up living under an overpass and unsure how to ask for help or explain his homelessness until a Douglas County deputy connected him to Ready to Work. Within hours he had a roof over his head, a meal, and case manager. "It was the best thing that's ever happened to me." Quickly embracing the program he moved from intern to trainee on an outdoor work crew to a LEAD candidate mentoring others. Now graduated and working for a major commercial builder, he reflects on how initially daunting the program's length was, "It was the fastest nine months of my life. I thank God I got here."

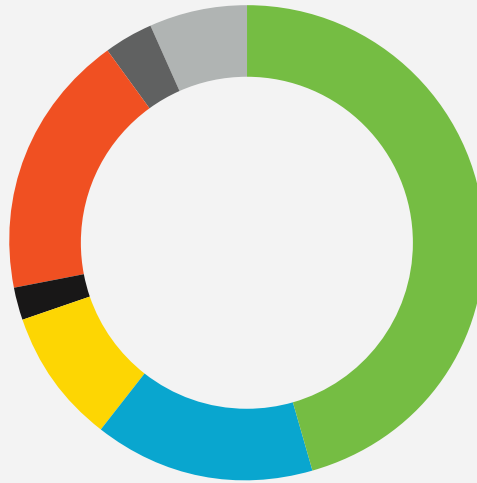

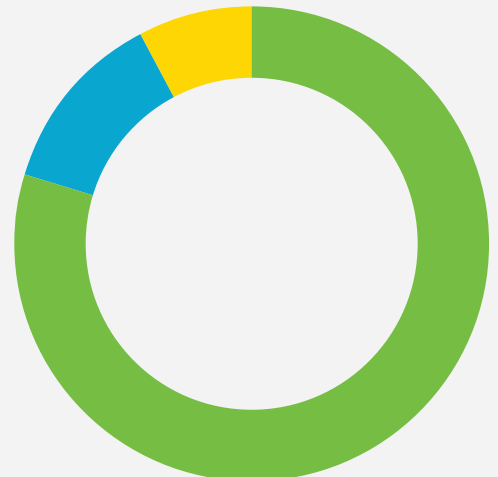
