"I'm grateful. This place saved me."

The first thing you notice about Mike L is his smile and contagious laugh—but you wouldn't have seen that a year and a half ago. After a decade living in his car, moving from truckstop to park, he was at his lowest—facing homelessness, addiction, and COPD, and praying for death. A stranger's kindness and a connection through Northglenn PD's navigation program led him to Ready to Work in Boulder, where he enrolled within a week.

Now 16 months sober, a crew supervisor with stable housing, and the program's 600th graduate, Mike says it simply: "I'm grateful. This place saved me."

“Give a year of your time and you come out a different person.”

After years of addiction, instability, and loss, Lisa H found hope and a fresh start through Ready to Work. Following a domestic violence incident, jail time, and meth addiction, she “lost everything.” While volunteering at the Denver Dream Center in 2024, a conversation with a peer support specialist there inspired her to make a life-changing decision. After touring the Aurora Ready to Work house, she returned home, flushed her meth, and applied to the program. Lisa graduated in 2025, earned parenting and healthy relationship certifications, and now works full-time as a Ready to Work kitchen manager. Most importantly, she rebuilt meaningful relationships with her two children.
